The Company wishes to alert its customers and members of the public to the internet websites with domain names stated below that refer to “惠理資本”, the English translation of which reads “Value Partners Capital”. The Fraudulent Materials make references to certain information of the Company including the Company’s name, logo, history, organizational structure, business address in Hong Kong, and Hong Kong stock code. In addition, a fake Certificate of Incorporation of the Company’s subsidiary Value Partners Hong Kong Limited and certain media articles published under the name of Value Partners Capital with mentioning of the Company’s Chairman and Co-Chief Investment Officer Dato’ Seri Cheah Cheng Hye were included.
